South Sudan

Introduction

1. The United Nations Security Council's sanctions list has been updated.

Notice summary (Full details are provided in the Annex to this Notice)

- 2. By virtue of the United Nations and European Union Financial Sanctions (Linking) Regulations 2017, the following entries have been <u>added</u> to the consolidated list and are now subject to an asset freeze.
 - Malek Reuben Riak RENGU (Group ID: 13698) (the "DP")
 - Paul Malong AWAN (Group ID: 13699) (the "DP")

Legislative Details

- 3. On 13/07/2018, the United Nations Security Council adopted Resolution 2428 (2018) concerning South Sudan, approving the addition of 2 entries to its list of individuals and entities subject to an asset freeze.
- 4. Unless the DP's are listed under EU Regulation 2015/735 by 12/08/2018, the asset freeze will cease to apply from 11:59 p.m. on 12/08/2018 until the date upon which the DP's are listed by the EU.

What you must do

5. You must:

- i. check whether you maintain any accounts or hold any funds or economic resources for the persons set out in the Annex to this Notice;
- ii. freeze such accounts, and other funds or economic resources;
- refrain from dealing with the funds or assets or making them available (directly or indirectly) to such persons unless licensed by the Office of Financial Sanctions Implementation (OFSI);
- iv. report any findings to OFSI, together with any additional information that would facilitate compliance with the Regulation;
- v. provide any information concerning the frozen assets of designated persons that OFSI may request. Information reported to OFSI may be passed on to other regulatory authorities or law enforcement.
- 6. Failure to comply with financial sanctions legislation or seeking to circumvent its provisions is a criminal offence.
