

Financial Sanctions Notice

23/01/2019

Ukraine (Sovereignty and Territorial Integrity)

Introduction

1. Council Regulation (EU) 269/2014 ("the Regulation") imposing financial sanctions against those undermining or threatening the sovereignty and territorial integrity of Ukraine has been amended so that an asset freeze no longer applies to the person listed in the Annex to this Notice.

Legislative details

- On 22 January 2019 Council Implementing Regulation (EU) 2019/92 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L 19, 22.1.2019, p.1) by the Council of the European Union.
- 4. The Amending Regulation amended Annex I to the Regulation with effect from 23 January 2019.
