# North Korea (Democratic People's Republic of Korea)

# Introduction

1. Council Regulation (EU) 2017/1509 ("the Regulation") imposing financial sanctions against North Korea (Democratic People's Republic of Korea) has been amended so that an asset freeze no longer applies to the persons listed in the Annex to this Notice.

#### Notice summary (Full details are provided in the Annex to this Notice)

- 2. The following entries have been <u>removed</u> from the consolidated list and are no longer subject to an asset freeze.
  - Kyu-Chang CHU (Group ID: 11029)
  - Yong-Chun KIM (Group ID: 11033)

#### Legislative details

- On 22 January 2019 Council Implementing Regulation (EU) 2019/93 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L 19, 22.1.2019, p.3) by the Council of the European Union.
- The Amending Regulation amended Annex XV to the Regulation with effect from 23 January 2019
