

Financial Sanctions Notice

Venezuela

Introduction

- 1. Council Regulation (EU) 2017/2063 ("the Regulation") imposing financial sanctions against Venezuela has been amended.
- 2. Identifying information for the individuals listed in the Annex to this Notice has been amended.

Notice summary (Full details are provided in the Annex to this Notice)

- 3. The following entries have been amended and are still subject to an asset freeze:
 - Gustavo Enrique GONZALEZ LOPEZ (Group ID: 13581)
 - Antonio Jose Benavides TORRES (Group ID: 13583)
 - Maikel Jose Moreno PEREZ (Group ID: 13584)
 - Katherine Nayarith Harrington Padron (Group ID: 13694)

What you must do

- 4. You must:
 - check whether you maintain any accounts or hold any funds or economic resources for the persons set out in the Annex to this Notice;
 - ii. freeze such accounts, and other funds or economic resources;

- refrain from dealing with the funds or assets or making them available (directly or indirectly) to such persons unless licensed by the Office of Financial Sanctions Implementation (OFSI);
- iv. report any findings to OFSI, together with any additional information that would facilitate compliance with the Regulation;
- v. provide any information concerning the frozen assets of designated persons that OFSI may request. Information reported to OFSI may be passed on to other regulatory authorities or law enforcement.
- 5. Where a relevant institution has <u>already reported</u> details of accounts, other funds or economic resources held frozen for designated persons, <u>they are not required to report these details again</u>.
- 6. Failure to comply with financial sanctions legislation or to seek to circumvent its provisions is a criminal offence.

Legislative details

- 7. On 9 July 2019 Council Implementing Regulation (EU) 2019/1169 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L 183, 9.7.2019, p.1) by the Council of the European Union.
- 8. The Amending Regulation amended Annex IV to the Regulation with effect from 10 July 2019.
