Egypt

Introduction

- 1. Council Regulation (EU) 270/2011 ("the Regulation") imposing financial sanctions against Egypt has been amended.
- 2. Identifying information for the individuals listed in the Annex to this Notice has been amended.

Notice summary (Full details are provided in the Annex to this Notice)

- 3. The following entries have been <u>amended</u> and are still subject to an asset freeze:
 - Mohamed Hosni Elsayed MUBARAK (Group ID: 11667)
 - Heidy Mahmoud Magdy Hussein RASEKH (Group ID: 11670)

What <u>you</u> must do

- 4. You must:
 - i. check whether you maintain any accounts or hold any funds or economic resources for the persons set out in the Annex to this Notice;
 - ii. freeze such accounts, and other funds or economic resources;
 - iii. refrain from dealing with the funds or assets or making them available (directly or indirectly) to such persons unless licensed by the Office of Financial Sanctions Implementation (OFSI);

- iv. report any findings to OFSI, together with any additional information that would facilitate compliance with the Regulation;
- v. provide any information concerning the frozen assets of designated persons that OFSI may request. Information reported to OFSI may be passed on to other regulatory authorities or law enforcement.
- 5. Where a relevant institution has <u>already reported</u> details of accounts, other funds or economic resources held frozen for designated persons, <u>they are not required to report</u> <u>these details again</u>.
- 6. Failure to comply with financial sanctions legislation or to seek to circumvent its provisions is a criminal offence.

Legislative details

- On 20 March 2020 Council Implementing Regulation (EU) 2020/416 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L 86, 20.3.2020, p.3) by the Council of the European Union.
- 8. The Amending Regulation amended Annex I to the Regulation with effect from 21 March 2020.
