Monthly Insurance Assessment and Licensing Committee (IALC) Application Review

There were eight insurance applications reviewed in November 2020, three of which were carried forward from prior months. Six of the applications were approved, one was deferred and one was declined.

Registration/licensing of approved insurance entities is subsequent to the IALC application process and may be confirmed in future periods.
