## Monthly Insurance Assessment and Licensing Committee (IALC) Application Review

There were 11 insurance applications reviewed in May 2021 three of which were carried forward from prior months. Seven of the applications were approved, four were deferred and one of the applications that was deferred was subsequently withdrawn.

Registration/licensing of approved insurance entities is subsequent to the IALC application process and may be confirmed in future periods.
