### **Consolidated List – Change Notice**

#### Introduction

- 1. The Transition Period ended at 11:00pm on Thursday 31 December 2020.
- 2. Implementation of the sanctions regimes referred to in the notice now takes place through new legislation, in the form of regulations made under the <u>Sanctions and Anti-Money Laundering Act 2018 (the Sanctions Act)</u>. The Sanctions Act provides the legal basis for the United Kingdom to impose, update and lift sanctions after formally leaving the European Union.
- 3. Following the publication of the UK Sanctions List, information on the HM Treasury Consolidated List for all financial sanctions listings has been updated. This means the following:
  - Regimes have been implemented under the Sanctions Act and their listings updated in line with the UK Sanctions List, with some regime names changing.
  - A number of entries are not designated in regulations made under the Sanctions Act and are not subject to an asset freeze or listed on the Consolidated List.
  - Several entries have moved to other regimes.
  - Additionally, some information has been merged into other listings.

- 5. The UK Freezing Orders asset freezing regime will remain in place under the Anti-Terrorism, Crime and Security Act 2001.
- 6. 113 entries previously designated under EU Sanctions Regulations have not been designated in regulations made under the Sanctions Act and are no longer subject to an asset freeze under UK legislation.

- 7. 11 entries have been incorporated in the Consolidated List as aliases of existing entries (but do not have a separate listing).
- 8. 10 entries have been designated under regulations made under the Sanctions Act where the title of the regulations under the Sanctions Act refers to a different regime than the EU regulation under which these entities were previously designated.
- 9. 7 UN listings no longer have an asset freeze associated with their UK listing so have been removed from the Consolidated List of financial sanctions targets. They remain listed with a travel ban on the UK Sanctions List.
- 10. 1 entry was formerly listed under multiple regimes. The entry is now listed under the Iran (Nuclear) regime only.
